



## Milestone 3: List of data sources on oral health care (WP2)

Version 1 - December 2024

## **Background**

Oral diseases affect all age groups, are among the top five most expensive diseases, and can be found in around half of the population in the European Union (EU). The 2021 WHO Oral Health Resolution highlighted major challenges in the financing of oral health care, such as the lack of access to essential oral health care without financial hardship for many EU citizens. However, there is no EU-wide harmonized framework for cross-country monitoring of oral health systems performance to date.

Therefore, the PRUDENT (Prioritization, incentives and Resource use for sUstainable DENTistry) project aims to develop and implement an innovative and context-adaptive framework for optimized financing of oral care. In particular, PRUDENT aims to develop a multi-country monitoring framework for oral health systems performance. Based on the framework, existing data sources will be integrated in an interactive cross-country dashboard. This dashboard seeks to facilitate better informed decisions on the financing of oral health care by health policy- and decision makers in Europe.

## Aim of milestone 3 in work package (WP) 2

To identify relevant European data and data sources on outcomes, risk factors and determinants of oral health.

## Methods

Using a mixed-methods research approach, PRUDENT will co-develop oral health system performance indicators and implement them in EU-wide monitoring framework (WP 2, T2.4 and T2.5). The first step is to identify existing databases with data on oral health for EU countries (milestone 3):

- 1) Online search of available public data sources with relevant oral health system information for EU countries
- 2) The partners and collaborating stakeholders of the PRUDENT consortium are asked to identify further potentially suitable data sources during the entire project phase.

Therefore, the following list of data sources in Table 1 (version 1 as of December 2024) is work in progress and will be updated, if applicable.
